north of Toronto, excellent access is provided to the amenities of town in Toronto, Eureka, and Yates Center. Approximately 12 acres at the south end of the property has been utilized as hay meadow, while the remainder of the property consists of pasture and trees. This property would serve as an excellent rural getaway or location to build a house or barn home, or park a camper. Located near Toronto Lake, this property offers quick and easy access to added bonus lake enjoyment and recreation!

ABOUT TORONTO LAKE: Toronto Lake is located in the scenic valley of the Verdigris River, just south of the town of Toronto. It lies at the northern end of the Cross Timbers area, which extends through eastern Oklahoma into northern Texas.

In Kansas, this region is known as the Chautauqua Hills and has a diversity of habitat for the visitor to explore. The characteristic habitat of the area is upland woodlands on sandstone outcrops dominated by post and blackjack oak, surrounded by terraces of prairie and gently rolling terrain gradually sloping to the water's edge. Duck Island and the upper half of the lake (both land and water), have been licensed to the Kansas Department of Wildlife and Parks and is managed primarily for public hunting of upland game, waterfowl and deer.
